### Panel 1: International cooperation to foster integrity

Panel 3: Know your business partner – and make a difference: Supply chain due diligence, social compliance and remedial action

Small and medium-sized enterprises form the backbone of the economy in most countries of the world and many of them are integrated in global supply chains. The international anti-corruption laws with extraterritorial application, the new German Supply Chain Due Diligence Act and various legal systems require companies to exercise care in dealing with their suppliers and third parties. In the past, some companies have tried to limit their responsibilities contractually so as not to have to deal with the business model and integrity of their third parties. This approach is no longer an option.
